1. **NO ALCOHOL OR DRUGS ALLOWED ON GROUNDS, THE MEDICAL FACILITY RESPONSIBILITY IS THE FEDERAL VETERANS ADMINISTRATION AND THUS GOVERN BY FEDERAL LAWS.**
2. **NO KNIVES, GUNS, OR WEAPONS OF ANY KIND ARE ALLOWED.**
3. **NO SMOKING IN NON-DESIGNATED AREAS, SMOKE IN DESIGNATED AREAS THAT ARE PROVIDED ONLY.**
4. **NO SHARING OF ANYTHING.**
5. **PETS ALLOWED IN DESIGNATED PET AREA ONLY.**
 - A. **PET CONSENT FORM MUST BE FILLED OUT AND ON FILE FOR PETS RECEIVING TREATMENTS (VETERINARY SERVICES) AND ALL THOSE STAYING OVERNIGHT.**
 - B. **CERTIFIED SERVICE DOGS ALLOWED WITH SPECIAL ARRANGEMENTS.**
6. **BACKPACKS, HANDHELD, OR ANYTHING THAT CAN BE CARRIED RULES:**
 - A. **ALL ITEMS ARE SUBJECT TO BEING SEARCHED BY SECURITY.**
 - B. **ALL BACKPACKS MUST BE CHECKED INTO SECURE STORAGE (STA 3A).**
 - C. **OVER NIGHT PERSONNEL MUST HAVE PERSONAL ITEMS CHECKED INTO SECURE STORAGE (STA 3A), ALSO REFER TO SPECIAL OVER NIGHT RULES.**
 - D. **ONCE LEAVING THE STAND DOWN FACILITIES RE-ENTRY IS RESTRICTED.**
7. **WRIST BANDS ARE ISSUED FOR SECURITY REASONS, DONOT REMOVE OR TRADE.**
8. **FOR SECURITY REASONS CERTAIN AREAS ARE OFF LIMITS, CHECK WITH STAFF OR SECURITY.**
9. **ONLY VETERANS ARE ISSUED DEPARTMENT OF DEFENSE (DOD) ITEMS.**
10. **OVERNIGHT VETERANS AND/OR DEPENDANTS: AFTER REGISTRATION YOU ARE NOT ALLOWED TO LEAVE THE GROUNDS, UNTIL AFTER CLOSE OF THE STAND DOWN HAS BEEN ANNOUNCED**
 - A. **IF YOU LEAVE EARLY YOUR ISSUED ITEMS WILL REMAIN ON STAND DOWN GROUNDS AND BE TURNED INTO SECURITY.**

Note: overnight veterans are issued DOD items not normally distributed to those that choose not to stay the duration.
 - B. **IF YOU HAVE NEED OF ITEMS FROM YOUR VEHICLE YOU WILL BE ESCORTED BY SECURITY AND ALL ISSUED ITEMS SHALL REMAIN IN THE COMPOUND.**
 - C. **FOR SECURITY REASONS ALL MUST BE ESCORTED TO CERTAIN AREAS OF THE COMPOUND, CHECK WITH TENT LEADER, STAFF, OR SECURITY.**
 - D. **ALL BACKPACKS, HANDHELD, OR ANYTHING THAT CAN BE CARRIED AND/OR PERSONAL ITEMS MUST BE CHECKED IN AT THE TIME OF REGISTRATION AND PLACED INTO SECURE STORAGE.**
 - E. **SECURE STORAGE, NO ONE IS ALLOWED IN THIS AREA WITHOUT SECURITY ESCORT AND NO MEDICATIONS OR MEDICAL DEVICES ALLOWED IN THIS AREA.**
 - F. **ALL MEDICATIONS AND MEDICAL DEVICES WILL BE TURNED INTO THE VA, AVAILABILITY AT NIGHT WILL BE HANDLED BY SECURITY.**
 - (1). **INCLUDES DIABETIC METERS OR/AND ANY OTHER MEDICAL DEVICES.**
 - (2). **DIABETIC FOOD IS AVAILABLE.**
 - (3). **NOTIFY TENT LEADER OF ANY MEDICAL ISSUES.**
